



# FUTURE SALON PROFESSIONAL SCHOLARSHIP APPLICATION

## Overview

This Future Salon Professional Scholarship was created by the Regis Corporation to recognize African American future professionals in the cosmetology industry. The scholarship award limit is \$1,000 per student.

The Scholarship Review Board will examine the applicant's leadership qualities, cosmetology interest and other personal traits which demonstrate motivation, passion, creativity and career potential within the Cosmetology industry. Applications are reviewed on a quarterly basis (i.e., 1<sup>st</sup> of January, April, July and October). Scholarship recipients will be notified of the award by their Academic Director/Executive Director.

## Eligibility Requirements

- First-time (full or part-time) student enrolled in the Cosmetology/Hairstyling Program (Re-enrollments and transfer students are not eligible);
- Non-Pell eligible African-American individual; and
- Applicant may not be a relative of an Empire Education Group or Regis Corporation employee.

## Directions for Applicants

Return the completed application form and required documentation to your Academic Director or Executive Director after you have received your final Financial Assistance Award Letter.

<b>1. Signed, Completed Application Form</b>
<b>2. Final Financial Assistance Award Letter</b>
<b>3. Essay</b> explaining your interest in the Cosmetology Program Include an essay titled, <i>"Why I decided to pursue a career in Cosmetology"</i> .
<b>4. Outline</b> of your career goals.
<b>5. Two letters of reference</b> pertaining to your leadership qualities, character, personal attributes and potential.  Reference letters may be provided by educators, guidance counselors, clergy members and other non-family members. Letters from family members are not considered.
